To Our Valued Partners,

Thank you for your continued partnership with Ace Sanitary. Like many companies, our business continues to be disrupted by recently enacted global tariffs. Multiple tariffs have gone into effect since our last announcement. Below is summary of the tariffs affecting our supply chain and resulting adjustments to our pricing:

Note: The above tariffs include announcements to date. Additional tariffs will be addressed separately if or when enacted as will any reductions or repeals.

We are taking steps to mitigate the impact of the tariffs that include partnering to absorb a significant portion of tariff-based inflation, most notably on stainless steel fittings with applicable tariffs of 45%. We will continue to do so, however, can no longer absorb the cost increases affecting our products today.

Therefore, effective April 14, you will see price increases based on product material type. As tariff details and negotiations continue to play out in real time, the ongoing uncertainty means that additional price increases may be necessary. We will communicate any further changes as they arise.

All orders placed prior to April 14<sup>th</sup> will be honored at current prices subject to availability of existing inventory. New orders placed on or after April 14 will be subject to the new pricing.
